- Attach a copy of your transcript or diploma issued by the ministère de l'Éducation et de l'Enseignement supérieur mentioning that you have passed your DEP;

- **more than 90 days**

- Please give your permanent code in section 1. Identification;

#### **You hold a DEC or an AEC:**

- Please give your permanent code in section 1. Identification

**AND**

- Attach the original of your college studies report card or your provisional attestation (the document will be returned to you by mail).

3. Enclose your \$110 payment. Cheques and money orders must be made out to the order of the Commission de la construction du Québec.
4. Enclose the form *Application for registration or modification of identification file or choice of union association*, duly filled out.
5. Enclose a photocopy of an official recognized document (Québec driver's licence, health insurance card, birth certificate or passport). Consult the complete list at [ccq.org](http://ccq.org).
