If you receive the payment of your pension by cheque, don't forget to notify the Commission de la construction du Québec when you change your mailing address, because payment of your pension will stop if there is an incorrect address in your file.

# SUPPLEMENTARY TAX DEDUCTIONS AT SOURCE

You must inform us of all desired changes that may lead to an increase in your tax deductions at source. In such a case, you must send us the following forms:

#### - Source Deductions Return (TP-1017 – provincial)

#### Personal Tax Credits Return (TD1 – federal)

You may obtain this form by going to a Canada Revenue Agency office or online at cra.arc.gc.ca.

## DIRECT DEPOSIT OF YOUR PENSION

- 2. Choose the "Dépôt direct" section.
- 3. Enter your bank information (printed on a cheque or in your online bank account).

Register for direct deposit to receive the following payments directly in your bank account:

- Vacation pay
- Health and dental insurance claim reimbursements
- Salary insurance benefits
- Monthly pension benefits
- Lump-sum pension benefits



If you have not yet subscribed to the CCQ's online services, visit our website, sel.ccq.org.

Your annual pension deposit statement will be sent to you by mail.

People residing outside of Canada are not eligible for the direct deposit service.

Surviving spouses who receive a pension are eligible for the direct deposit service, but may not subscribe to the CCQ's online services. In this case, contact our customer services.

Please note that when there is a death, all transactions made in the deceased's account are usually suspended until the estate is settled. To avoid this inconvenience, we strongly recommend that your pension be deposited in a personal bank account that is not a joint account.
